Door County is Spectacular with more than 250 miles of picturesque shoreline! Visit the historic village of Ephraim, a working fishing port, Sister Bay where goats might be the most famous residents and some of the best shopping in Fish Creek and Egg Harbor. Watch a beautiful sunset over Green Bay at Sunset Park.

Sun. - Sep 26 (Day 1)

Late afternoon departure from Lansing for Ludington, and our hotel for the night before we sail early the next morning. Overnight: Best Western-Ludington

Mon. - Sep 27 (Day 2)

After breakfast at the hotel, board the SS Badger, the largest car ferry sailing Lake Michigan for more than sixty years. The S.S. Badger is a national treasure, offering a cruise experience that links us to an earlier time when a sea voyage was the ultimate travel and vacation adventure. Enjoy the leisurely 4 hour crossing and arrive in Manitowoc, WI just prior to noon (WI time). We re-board our motor coach and head north to Door County. Visit the Door County Winery for wine tasting/shopping and continue to our lodge with a few photo stops along the way. Check into our lodge for the next three nights. Dinner this evening will be at a local restaurant. Return to our lodge for a relaxing evening by visiting around the firepit or take a swim in the indoor pool. Overnight: Open Hearth Lodge (B,D)

Tues - Sep 28 (Day 3)

After breakfast at the lodge, depart for a county park and some wonderful scenery on the Lake Michigan side of the peninsula including amazing views of the Niagara Escarpment. Then, enjoy a Swedish brunch at **Al Johnson's Restaurant**, where you can find goats grazing on the sod roof all day long, always a highlight. Explore more of the peninsula with breathtaking views of Green Bay at Ellison Bluff County Park. More sights and small villages as we work our way to Sturgeon Bay in southern Door County for dinner at a local restaurant. Return to the lodge for another relaxing evening. Open Hearth Lodge (B,Brunch,D)

Weds. - SEP 29 (Day 4)

After breakfast at the lodge, travel north for a drive through Peninsula Park for magnificent views and visit the Eagle Bluff Lighthouse. Travel to the northern tip of Door County to Gills Rock where ferries depart for Washington Island. Time for browsing in local shops and walking along the coast. Visit a farm market to enjoy local foods, produce and shop for local gifts. Explore more of Door County this afternoon before visiting Fish Creek to explore the history and quaint shops. Tonight, we experience one of **Door County's famous Fish Boils**. This feast is a tradition passed from generation to generation. Celebrated at its traditional best, as the technique has been preserved and passed down from the Master Boiler's grandfather, to his father, and now to the son. Return to the lodge. Overnight: Open Hearth Lodge (B,D)

Thurs. – SEP 30 (Day 5)

Morning departure for southern Door County and a stop at Renard Cheese is always a fun and tasty experience. Continue on to Manitowoc to board the ferry and sail back to Ludington. Be sure to grab a meal on the ferry as we arrive Ludington at 7:00pm and will continue on to Lansing arriving around 9:30pm. (B)
